



HOLD HARMLESS / RELEASE AGREEMENT
With Additional BARK ATL Policies Included

TEMPERAMENT:

BARK ATL screens dogs for temperament and we EXCLUDE aggressive dogs from our facility. However, dog day care can be hazardous. We are not responsible for injuries and/or death that may occur in and out of the day care including the transporting of animals.

_____ (initial) I am aware that I am placing my dog in a sociable setting, and that I will be held responsible for my dog's behavior.

_____ (initial) I certify that my dog is not aggressive toward people or dogs, and has never shown signs of aggression of any variety.

_____ (initial) If my dog attacks a person or another dog while under the care of BARK ATL, I understand that I will be held responsible for medical costs incurred as a result of my dog's aggression.

MEDICAL CARE/HEALTH POLICIES

_____ (initial) If in my absence, my pet should become ill or injured, or in need of veterinary care, BARK ATL has my permission to consult with my veterinarian. If my dog should require immediate care, I hereby grant BARK ATL permission to transport my dog to the designated BARK ATL veterinarian. I understand that I am responsible for all veterinary costs, including the transportation of my pet to and from the veterinarian.

_____ (initial) I hereby declare that my dog has not been exposed to any communicable diseases within the last 30 days, and is fully vaccinated in accordance with BARK ATL policy.

_____ (initial) I do understand if my dog becomes ill with a communicable disease such as kennel cough or intestinal parasites that I am responsible for treatment and cannot return to BARK ATL, until treatment has been completed and my dog is not longer contagious.

REFUND POLICIES / PRE-PAID PACKAGES / LATE PICK UP POLICIES

_____ (initial) I am aware that all pre-paid packages (daycare and boarding) are non-refundable. No Exceptions. (Even in the event the dog is not allowed back at BARK ATL due to behavior / aggression issues and / or customer moves / relocates.)

_____ (initial) I am aware that all pre-paid packages expire 1 year after date of purchase.

_____ (initial) I am aware that if I am late to pick up my dog, a \$10 late fee will be applied for the first 15 minutes. If I am late more than 15 minutes, a \$15 late fee will be applied. If I am more than 30 minutes late, I am aware that my dog will be required to board for the night.

_____ (initial) I understand that BARK ATL cannot be held responsible for lost, dirty, damaged, or destroyed belongings left in BARK ATL care.
